Dear Parents,

The purpose of this letter is to update you with the upcoming implementation of the PARCC testing which will be administered on November 16 – 20. PARCC stands for Partnership for Assessment of Readiness for College and Careers which is aligned with the Common Core Standards. All students currently enrolled in Algebra I, Geometry, Algebra 2, English 9, English 10, and English 11 will be take the PARCC for the fall semester.

In the past, high school students were required to take the High School Proficiency Assessment (HSPA) in order to meet the New Jersey State graduation requirements. Since the spring 2015, PARCC has replaced that state assessment. Students must obtain a passing score on PARCC or pass one of the alternate assessments (in both Language Arts and Math) as listed in the following chart in order to fulfill their graduation requirements.
